26 – 28 October 2021

Does a common European culture of remembrance exist? Is it possible to create one narrative about the history of Europe? With these questions in mind, the European Network Remembrance and Solidarity invites institutions and organisations dealing with 20th-century history and history education to gather at the 9th European Remembrance Symposium. The event will be held on 26-28 October 2021 in Tallinn (Estonia) in a hybrid form.

Organised since 2012, the main goal of the Symposium is to exchange experiences and establish methods and forms of cooperation between institutions from all over the continent. This year's edition titled '**Memory and Identity in Europe: Presence and Future**' aims at reflecting on the role of 20th-century history and historical memory in contemporary European identity. Special attention will be given to the mission statements, programmes and best practices of institutions dealing with 20th-century European history. The confirmed panellists and moderators of the Tallinn Symposium include **Prof. Linda Kaljundi, Alicja Knast, Prof. Jeffrey K. Olick, Dr Gergely Pröhle, and Prof. Gesine Schwan.**


